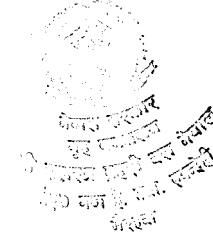

4. Sealed bids must be submitted in handwritten form to the concerned office as specified in the schedule before 12:00 PM on 2083/02/08. Bids received after this deadline will be rejected.

5. Bids will be opened on 2083/02/08 at 2:00 PM in the presence of the bidders' representatives who choose to attend the respective office as scheduled. Bids should be valid for a period of 45 days after the date of bid opening and should be accompanied by a bid security which shall be valid for 30 days beyond the validity period of the bid i.e. 75 days.

6. If the last date for submission of bids and/or submission falls on a government holiday, the next working day shall be deemed the last date. In such a case, the validity period of the bid security shall remain as specified for the original last date for submission of bids.
7. The bidder shall comply with the provisions of the Public Procurement Act, 2063 (latest amendment) Any clarification sought by the employer shall be provided in accordance with Sub-section 4 of Section 23 of Section
